Printing Records

Recently, I have learned that many of you need to print your individual records from a CenTrax file. Most of you accomplish this today by clicking "Print" while viewing that record in Browse mode (on the CRA or HMDA2004 tab). This can be quite tedious if you need to print more than one or two! There is an alternative that is much better, especially for those of you who need a sample of records or who need to print every record in the file.

From the main menu in CenTrax (with the file you want to work with set active) go to **Discovery, Research, Reports, System/Other, Customer Account Register**.

To print every record, select "All" as the **List Style**, for a selection of records choose "Sample" and then set the **Sample Method**. For Report Listing choose "Detail". This option provides one sheet of paper for each record and is identical to the page that prints from the Browse window.
